Shareholders in the Putnam Master Intermediate Income Trust on the record dates per the attached statement received distributions, a portion of which represent a return of capital. As a result of the non-taxable distributions, the shareholders of record will be required to reduce the basis in their RIC common shares of this fund by amounts designated as a return of capital.

The shareholders' basis in their shares of this RIC is reduced by the distributions paid during the calendar year 2023 which have been determined to be a return of capital. The impact to the shareholders' basis, on a per-share basis, can be found on the attached.

The Master Intermediate Income Trust had a return of capital of \$3,109,690 at its fiscal year ended 9/30/23. This represents 31.926257% of the 2023 calendar year distributions of \$9,740,227 which were paid in this fiscal year. See attached for per share amounts.
