The blended benchmark for the Age-Based Asset Allocation Investment Option is a blended customized index constructed by Putnam from up to eight unmanaged indexes that measure the markets in which the underlying investments invest. Indexes include the JPMorgan Developed High Yield Index, the Bloomberg Barclays U.S. Aggregate Bond Index, the MSCI EAFE Index (ND), the MSCI Emerging Markets Index (ND), and the Russell 3000 Index. Indexes assume reinvestment of distributions and interest payments and do not include fees. Bloomberg Barclays U.S. Aggregate Bond Index
