Retirement accounts (Page 2)

Any unallocated investments will be placed into Class A shares of the Putnam money market fund that corresponds with your status as an institutional or retail investor.

Non-retirement accounts (Page 3)

Class A, C, and M shares are available only on terms set forth in the prospectus under How do I buy shares. Check with your financial advisor on the availability of other share classes.

529 for America accounts (Page 4)

Fee Structures A, B, and C shares are available only under the terms set forth in the Putnam 529 for America College Savings Program Offering Statement sections "Fees and Expenses" and "Breakpoints".

Accounts established for beneficiaries 15 years of age or older are not eligible for fee structure B.
