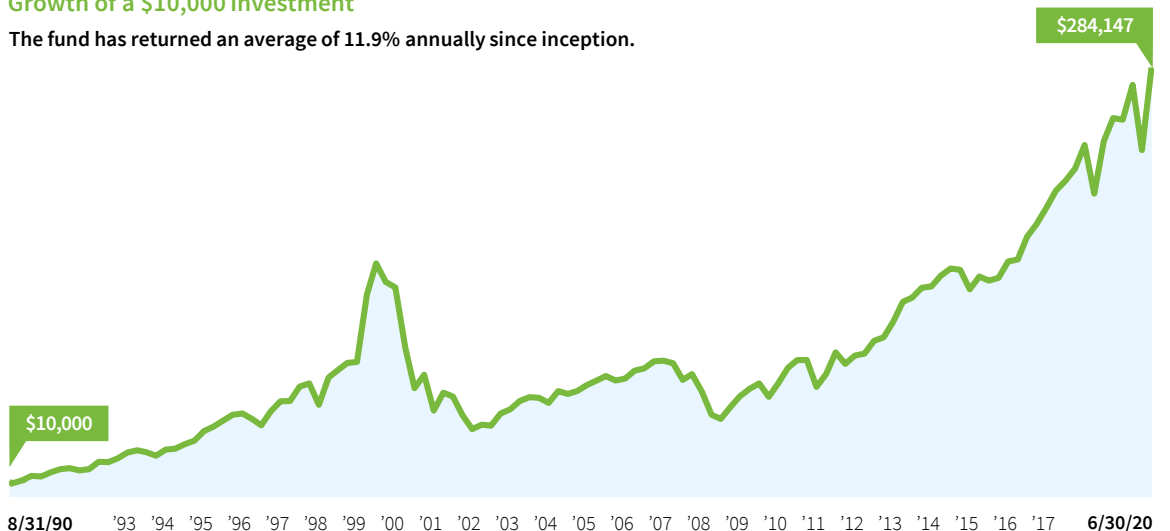

It is a historical measure of the variability of return earned by an investment portfolio. Risk statistics are measured using a 5-year regression analysis.
