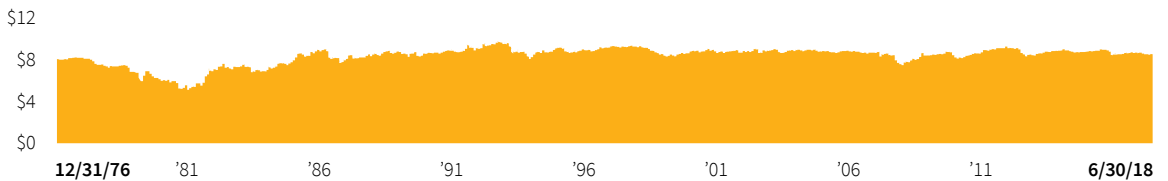

Sectors represent 100% of the portfolio and will vary over time.

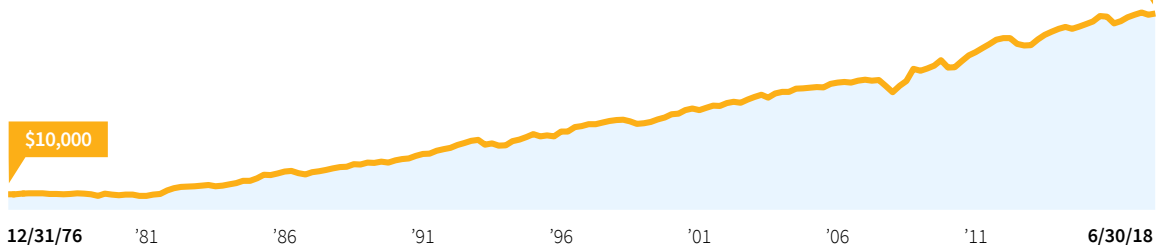
Protecting investors' principal, the fund's net asset value has remained stable
