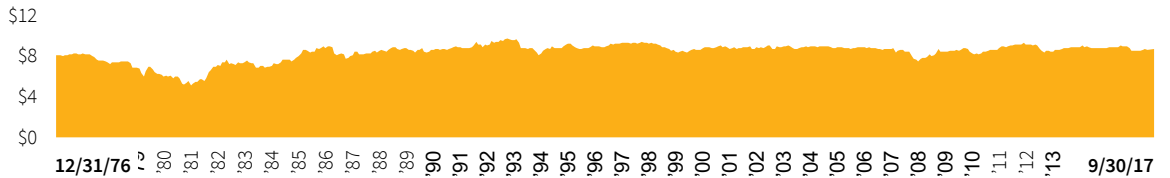

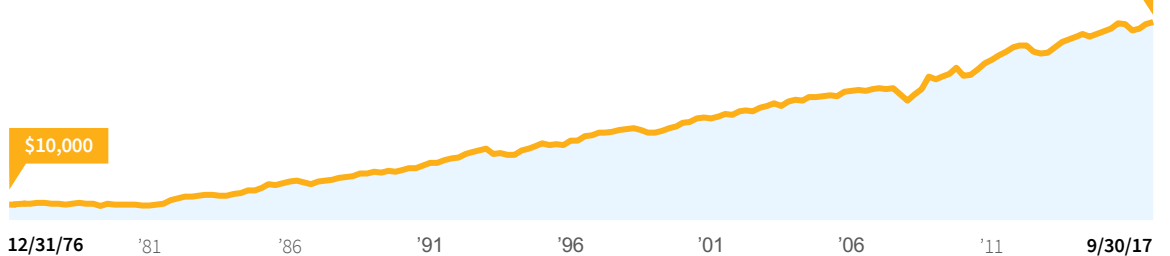
Protecting investors' principal, the fund's net asset value has remained stable

Duration to worst is the duration of a bond computed assuming the bond is called at the worst possible time and uses the date associated with the lowest yield. Depending on the interest-rate environment and structure of the bond, there may be scenarios in which the worst possible time for the bond to be paid off is the maturity date. **Average stated maturity** is determined based on the legal final maturity of a bond.

Average effective maturity takes into account the likelihood of the bond being called.
