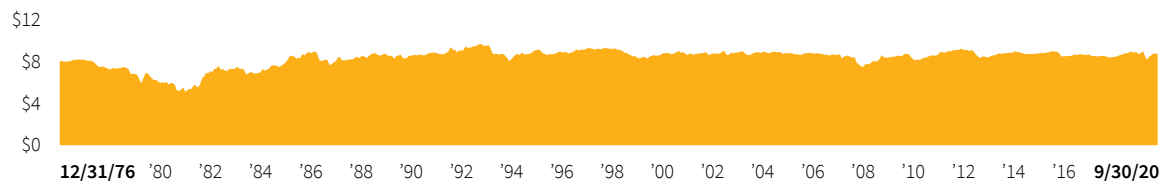

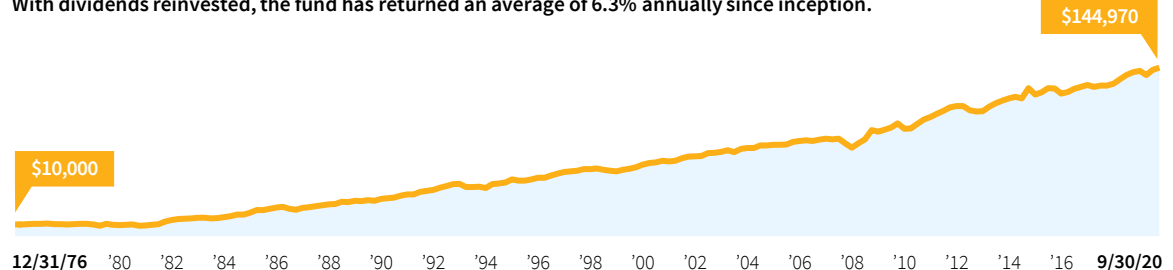
Protecting investors' principal, the fund's net asset value has remained stable
