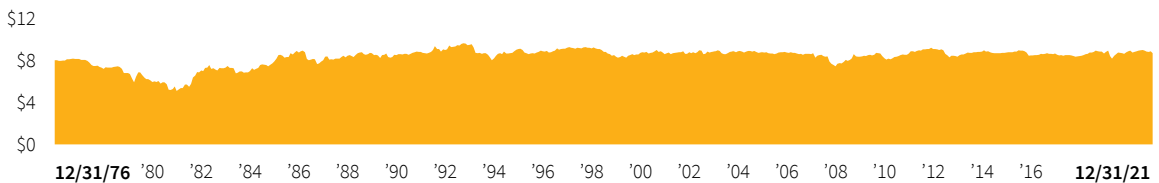
The fund invests 88.7% of its assets in investment-grade tax-exempt bonds.
