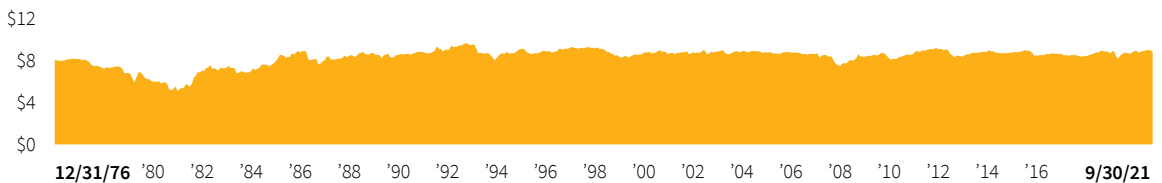
The fund invests 86.5% of its assets in investment-grade tax-exempt bonds.
