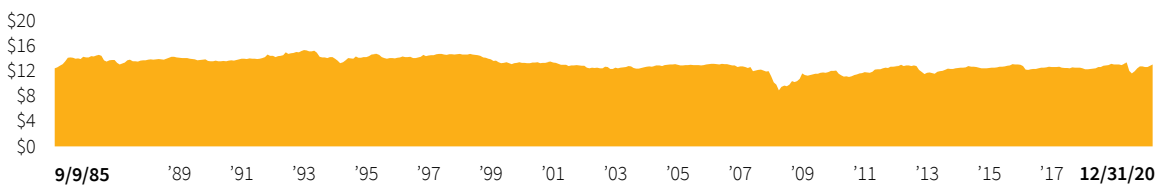
The fund invests 52.0% of its assets in investment-grade tax-exempt bonds.
