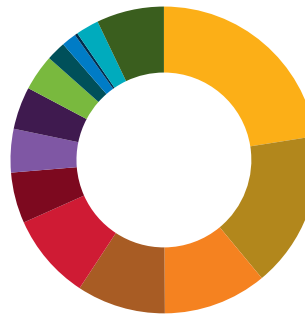

**Standard deviation** measures how widely a set of values varies from the mean. The longer a fund's duration, the more sensitive the fund is to shifts in interest rates.
