

The value of international investments traded in foreign currencies may be adversely impacted by fluctuations in exchange rates. The risks associated with bond investments include interest rate risk, which means the prices of the fund's investments are likely to fall if interest rates rise. Bond investments are also subject to credit risk, which is the risk that the issuers of the bond may default on payment of interest or principal.
