# Putnam Dynamic Risk Allocation Fund

A global allocation strategy that seeks a strong risk-adjusted return by allocating to four risk sources

**Risk-based allocation**

The fund allocates to four risk sources — equity, credit, interest rate, and inflation — to better balance equity risk and improve downside protection.

**Top-down flexibility**

The fund dynamically adjusts allocations to reflect our active top-down views of future risk-adjusted return potential.

**Bottom-up strategies**

The portfolio managers invest selectively in a range of lower-volatility and hedging strategies to further diversify sources of returns and manage risk.


