PUTNAM INVESTMENTS ANNOUNCES 19(a) NOTICES FOR <u>CLOSED-END MUNICIPAL FUNDS</u>

BOSTON, Massachusetts (July 8, 2020)- The 19(a) monthly distribution notices for Putnam Managed Municipal Income Trust (NYSE:PMM) and Putnam Municipal Opportunities Trust (NYSE:PMO) are now available. These informational notices provide further details on the sources of the funds' monthly distributions and follows the most recent distribution announcement.

The table below provides an estimate of the sources of the Fund's current distribution and its cumulative distributions paid this fiscal year-to-date. Amounts are expressed on a per share of common stock basis, and as a percentage of the distribution amount.
