Composition of composite: The Putnam Investments U.S. Small Cap Value Equity Composite (the "Composite") seeks to outperform the Russell 2000 Value Index by investing in a portfolio of stocks with attractive valuation and quality characteristics and improving business momentum or catalysts that can unlock value. The strategy focuses on bottom-up stock selection, well-diversified portfolios, and downside risk management and seeks to manage risk through security selection, portfolio construction, and liquidity management. The Composite's benchmark is the Russell 2000 Value Index. The Composite may contain accounts with different but largely similar benchmarks. Leverage is not utilized in any account in this Composite. However, derivatives (including futures, exchange-traded or OTC options, and swaps) may be used in some portfolios for hedging or non-hedging purposes.
