Shareholders in the Putnam Premier Income Trust on the record dates per the attached statement received distributions, a portion of which represent a return of capital. As a result of the non-taxable distributions, the shareholders of record will be required to reduce the basis in their RIC common shares of this fund by amounts designated as a return of capital.

The shareholders' basis in their shares of this RIC is reduced by the distributions paid during calendar year 2020 which have been determined to be a return of capital. The impact to the shareholders' basis, on a per-share basis, can be found on the attached.

The Putnam Premier Income Trust had a return of capital of \$8,375,073 at its fiscal year ended 7/31/20. This represents 33.252788% of the 2020 distributions which were paid in this fiscal year of \$25,186,077.51. See attached for per share amounts.
